

Entry requirements

- Satisfactory completion of VCE
- Units 3 and 4, a study score of at least 30 in English (ESL) or 25 in any other English
- Units 1 and 2, any two units from general mathematics and/or mathematical methods (either)

Credit and exemptions

Credits and exemptions may be considered for previous tertiary level or post secondary study undertaken not more than 10 years ago. Applications are considered individually and credit for previous studies is not automatic.

In2Monash is an online database for international students and non-school leavers to determine eligibility for admission to a Business and Economics course before the submission of an application.

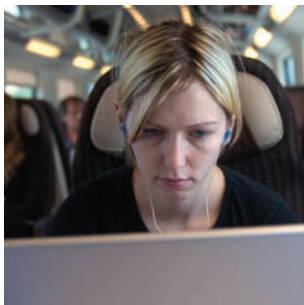

Bachelor of Business and Commerce (Global)

The Bachelor of Business and Commerce (Global) is an exciting new course offered at the Gippsland campus and via off-campus learning (OCL). This program provides high-achieving students the opportunity to study overseas and prepare for the rapidly changing global business environment.

The BBusCom (Global) incorporates the core units from the major business disciplines while enabling all students to study one semester with a partner institution to create a truly global degree.

This degree is ideal for students wishing to combine travel and study, to gain experience overseas and who aim to pursue careers in businesses with a global reach or with multinational corporations.

Features of the course

- Study a semester at your choice of partner institution (study abroad) or at a Monash campus overseas.
- Start your major from day one, or select your major after sampling each of the primary business disciplines.
- Qualify in two business areas by undertaking a double major.
- Expand your interests by undertaking elective units from other faculties.
- Undertake two specialised units *Issues in global business* and *Investigative project* designed to make your degree truly global.
- Graduate with a prestigious degree recognised by employers around the world.
- Access to academics and information from international guest speakers.

- Global experience drawn from living and studying in an overseas location.
- Increased independence and a unique global and intercultural perspective.
- Sound knowledge of the local and global business environment

Course structure

The BBusCom (Global) comprises 24 units that are normally completed over a three year period by full-time study, or six years if undertaken part-time.

Students must maintain a 60 per cent average in order to be eligible to study overseas.
